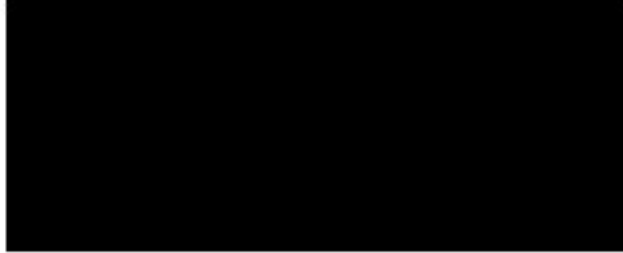

I have been given your details by Kay Meade, the principal planning officer at East Hertfordshire Council.

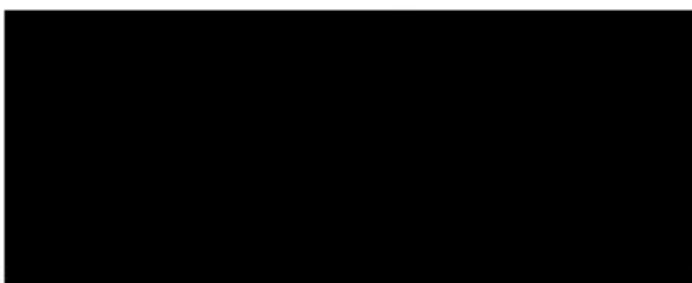
Kay has asked me to contact you in relation to a site at Mangrove Road, Hertford. Please see the attached site location plan. The Site is likely to be considered favourable for inclusion in the Submission Draft District Plan as a site allocation for residential units. Our preliminary studies indicate the site has capacity for around 50 – 65 dwellings and would be expected to come forward for delivery within the first five years of the plan period (2017 – 2022).

Kay asked me to contact you to seek confirmation from Hertfordshire County Council Education Team that the proposal is acceptable in principle.

Please can you confirm what additional information you need to provide the confirmation if any?
